One: Anonymous Feedback [Label: **New Initiative** ▾]

As usual, we worked on decentralised principles, i.e that different Circles can do things their own way, and we ask the community for its views before changes are made. We’d like to thank everyone who gave input to the decision process, and the Data Analytics Circle for analysing the input. We will now be taking note of the effects of the changes, and how people feel about them in practice.

Three: BGI Nexus [Label: **New Initiative** ▾]

Notes: The concept of third-party utilization of DeepFunding had been loosely discussed in the FG for some time. The friends at BGI Nexus helped make this a reality. DFFG spent several sessions discussing this new initiative and experiment. Three members attended an open office session with BGI Nexus to ideate and provide cross-culture insights on voting, review protocols, platform nuances and answer any

One: Community Hubs Review [Label: New Initiative Event Challenge]

Notes: During this month we had the Closure of the Community Hub RFP with 40 proposals for very Diverse Deep Funding Community Hubs. It was awesome to see so many proposals. However, this raised the need for the Events Circle to create a review process, with different rating criteria and a comparison sheet, where we added summarized and organized information about each of the proposals. We're following a careful balanced process where the three team members review each proposal and add their ratings. From there, we're creating our top 10, and coming together in a call to discuss strengths, weaknesses, and how each proposal fits within our general strategy to select the RFPs we will be able to fund. It won't be an easy choice as there are a lot of quality proposals because of this we see a possibility that Hubs who are not selected in this round are kept on a waitlist for the next set of hubs to be funded.

Two: Two New Members in Circle [Label: Event Decision New Initiative]

Notes: Since the end of the last month, we started our recruitment process. This involved clearly defining the requirements, skill set, and cultural fit we were looking for. We've reached out to applicants on the Community website, as well as leveraging our network and people who showed interest in being part of Circles.

We've done interviews to get to know each applicant, and while we had many great applicants we chose the two we believe we're an overall better fit for the team. Please welcome Mariam and Priscilla to the Events Circle.

This process, allowed us not only to recruit new members but also to establish processes for recruitment which was something we had never had to do.

One: Onboarding Processes - [Label: **New Initiative** ▾]

Notes: In adopting a descriptive approach to understanding and improving the onboarding process, we engaged with coordinators from various circles to gather insights and learn from their experiences. We reached out to them to find out if they had implemented any onboarding within their circle, the particular approaches they used, and the resources or guides they used. Also, we inquired about the effectiveness of their processes, including any challenges or barriers they encountered along the way. To organize and visualize this information, we created a Miro board that mapped out these onboarding processes used by the different circles. This visual representation not only showed us the variety of approaches but also as we work on it, it will help us identify common obstacles, best practices, and areas for improvement.

Notes: After deciding to add two more people to the circle, we carefully reviewed all the applications in the circle application spreadsheet and took the time to look for applicants whose skills and experience aligns with the circle's goals. We have identified these persons and we will be reaching out to them to confirm their interest and availability.

Notes: We agreed on the approach we would take to facilitate the onboarding process in the Deep Funding community. We outlined the specific tasks required by this circle to ensure a smooth and effective transition for new members into various circles. These

One: Completed the test with CES tool provided Photrek for the community engagement and voting reputation. [Label: Event Milestone]

Notes: In February, we tested the Community Engagement Score (CES) Tool by Photrek to assess its accuracy and performance for Deep Funding Round 4 (DF4).

Key Findings:

- **Data Accuracy & Algorithm Validation:** The tool correctly processes engagement data and applies the expected scoring logic.
- **Performance Under Load:** Efficient in handling large voting snapshots.
- **User Experience:** While powerful, it requires guidance for non-technical users (manual available).
- **Result Comparison:** The tool's results matched manual calculations, but an average proposal grade discrepancy (7 vs. 9.11) is under review with Photrek.

Test results, voting data, and methodology are documented. The CES Tool Manual provides further guidance. **Here is the manual for the CES Tool:**
